- Enhances the capacity of beneficiary states to prevent and respond to threats posed by international criminal activity, thereby contributing to a full range of Canadian security and foreign policy interests.
- Supports capacity building projects of foreign states through the provision of training, equipment and technical assistance in thematic areas.
- Projects are delivered through partnerships with international organizations, close allies, NGOs and other Canadian government departments.

## ASSISTANCE IN MEXICO IS DELIVERED BY MULTIPLE PARTNERS, INCLUDING:



### ENHANCING BORDER SECURITY (2018-2021)



Enhance the capacities of Mexico's Tax Service Administration Service  and the National Immigration Institute  to better identify and interdict contraband, drugs and imposters, in order to disrupt smuggling routes and irregular migration.

### HUMAN SMUGGLING MIGRATION OPERATION AND TRAINING (2020-2022)

Enhance the Mexican national intelligence and other relevant government agencies in Mexico with a goal of disrupting and deterring human smuggling and other transnational crimes.



### DETECTION AND PREVENTION OF HUMAN TRAFFICKING WITHIN INDIGENOUS COMMUNITIES IN MEXICO (2017-2021)

Technical assistance project in selected pilot communities with the objective of detecting, preventing and combating human trafficking among indigenous groups, addressing local and transnational dimensions.



### ACCESS TO JUSTICE FOR CHILDREN AND YOUTH IN MEXICO (2017-2025)

- Phased approach to strengthen youth justice policy development and program design in Mexico.
- **Phase 1** consisted of Canadian and Mexican juvenile justice experts sharing best practices that promoted human rights, restorative justice, social prevention of crime and alternatives to imprisonment.
- The project also developed a successful Youth Post-Sentence Companion Pilot Program in collaboration with the State of Yucatan.
- **Phase 2** would replicate the piloted process in other selected states and will also include cooperation on the prevention of domestic violence.



### PREVENT, COMBAT AND MITIGATE CYBERSECURITY THREATS (2019-2023)

Reduce the full range of threats to Canada from overseas, while promoting an open, secure and resilient cyberspace through international cooperation based on institutional structures established as a result of the implementation of National Cybersecurity Strategies and greater participation in the dialogue on international norms in cyberspace.

### EARLY WARNING SYSTEMS IN RESPONSE TO OPIOIDS AND NEW PSYCHOACTIVE SUBSTANCES (2020-2022)



Support training for Early Warning Systems in all OAS members, except Nicaragua, and further the development of drug information networks in targeted countries. The project will produce analytical reports, provide national and regional training, develop manuals and standard protocols, and ensure collaboration with other international agencies.



### PROTECTION OF CROWDED SPACES AND OTHER VULNERABLE TARGETS (2020-2023)

Provide a consolidated and tested methodology to efficiently design and implement integrated safety and security plans to protect crowded spaces and vulnerable targets threatened by terrorists or criminal organizations, such as in major events and/or tourism destinations.
